## Challenge

**FireEye needed to ensure security compliance across their organization to eliminate any client concerns.** They decided that a consistent, repeatable, security training solution would work best.

The solution provided stakeholders with the ability to track each learners' progress and map their learning to their overall career goals.

FireEye initially introduced security awareness training to their technical teams, who were assigned the foundational Security Compass courses, including **Secure Software Development Concepts**. This course is part of the industry-recognized Software Security Practitioner (SSP) suite and contains learning paths which enable FireEye's employees to be SSP-certified upon completion.

They then expanded the solution to include all employees across their organization, ensuring that employees were assigned to courses based on their role and level of expertise. By implementing security training for all new and current employees, FireEye developed a systematic approach to learning which ensured compliance throughout the organization and helped them tackle any current or prospective customer concerns.
